An amount of \$8,000.00 was proposed, but Oppong turned that down and called for \$12,000.00. That was negotiated down by Okyere to \$8,500.00. This was not accepted. Oppong finally pegged the firmly at \$10,000. Okyere did not have a problem with the price and agreed to pay same. Upon speaking to his bankers he realised that his bank balance was \$9,000.00. Okyere called Oppong on the 14th of December 2000 to reduce the consideration to enable him purchase the land. On the 15th of January 2020 Oppong returned Berko's call to say he may be willing to consider the amount anyway. On a second thought, Oppong felt forced to sell the land to Berko on the 16th of December 2020 for an amount of \$9,500.00. This was after Berko woke up to see 80 missed calls from Oppong. Berko needed this land to construct a factory to create job opportunities in the community. COMPULSORY QUESTION

Frimpong and Ken, two level 100 class repsin the Accounting Department of CBS, convinced their mates to organise a party on February 14to celebrateValentine's Day. Each student was to contribute GHC200.00 which was to be used to buy gifts, book a venue and engage a disc jockey (DJ). The two guys visited the Junction Mall in Accra and had a good time moving from one shop to the other enquiring on what possibly will be a good package as gifts—for the occasion. After about two hours of gallivanting at the mall, they decided to abandon their mission as either the items were too pricy or simply not suitable for the occasion. Just when they were exiting the premises they were called back by one shop attendants who stated that her manager wanted them to return and check out some package.

In the shop the two friends met the manager who stated "young men, I'm told you need some gifts for your mates in school. Come, and let me show you around to our shop floor upstairs" the manager took them upstairs, which was not previously visited earlier when they visited that same shop that morning. The manager took them from one shelf to the other when various items were displayed with their price tags on them. The manager added "these items were imported from Britain and are of a high class. We have neatly arranged them upstairs here for special customers. For this valentine we have decided to offer all the items at a 10% discount to students. Please feel free to accept our offers which come with two weeks guarantee."The two friends then walked from shelf to shelf and selected a number of items into their trolleys.

At the counter they observed that they were running out of money and may not have enough money to book the party venue and pay 50% of the disc jockey's fee.

They therefore decided to return some of the items and pay only for the items in Ken's trolley. Just when they were returning the items the manager stopped them and indicated that items picked from the shelf were not returnable. Especially because the two friends were his first ever customers for the day and did not want any bad luck by returning the items. He went on to say that "I told you when you entered the shop that the items offered to you are quality items and so I don't see why you even want to reject them". The two friends resisted this and insisted on paying for items in one trolley. This degenerated in a heated argument making the two friends finally deciding to walk out of the shop without even paying for the other trolley. In the course the argument Ken's students ID card fell on the floor without his knowledge.

Two weeks later, the manager used Ken's ID card to track him to the campus and served him with a court action. Ken and Frimpong are worried and have consulted you for legal advice. Please advice him with the aid of legal cases
