- 1. Cynthia Amankwaah is a public figure in Ghana who has starred in several movies and has had a successful music career spanning over a decade. Within the country, she is regarded as a celebrity who is often times flanked by members of the paparazzi who try to get her pictures printed in magazines and online social media sites. This past April, Cynthia's sister, Abena, got married. In order to prevent access to the event by members of the paparazzi and uninvited persons due to Cynthia's presence, the family decided to host the wedding in a secret location, a private island, with access to the event strictly by invitation. During the course of the planning of the event, Cynthia contemplated selling her images during the wedding to a specific magazine, I'm Aware, granting them the sole right to publishing images from the event. During the day of the event members of the paparazzi, without consent and authorization, got access to the pictures and intend to publish them without her approval.
- In the case that Cynthia's images during a private event were taken and published by unauthorized parties without her consent despite being a public figure, advise the course of action Cynthia should take against the magazine?
